

Identification and Assessment

To record the approximate numbers of five organisms collected in each taxa found in the stream reach, use letter codes: R (rare) for 1 to 10; and C (common) for 11 or more. **Do NOT count empty shells, pupae, or terrestrial macro invertebrates.
